Assistant District Attorney Jessica Melton is the Chief of the Human Trafficking Bureau of the Queens County District Attorney's Office. She is a graduate of St. John's University School of Law and has been a prosecutor with the District Attorney's Office for the past twenty years. Since New York State's first Sex and Labor Trafficking laws took effect thirteen years ago in 2007, she has focused her career solely on the prosecution of human trafficking and related crimes. Most notably she obtained the first conviction for sex trafficking in New York State after a jury trial in which the defendant was sentenced to 25 years to life in prison and also obtained the first labor trafficking conviction in Queens County. In 2013, she was awarded the prestigious Thomas E. Dewey medal by the New York City Bar Association for her work in combating Human Trafficking.

Restore NYC exists to end sex trafficking in New York and restore the well-being and independence of foreign-national survivors.










Phases of Disaster

Tori Curbelo, Manager of Education, Training, & Advocacy







What sets LifeWay's Safe Housing Program apart is its community living model. It goes beyond offering shelter by welcoming each woman into a supportive, caring environment that helps them recover from their trauma, regain their sense of self-worth, and enables them to move from isolation towards reclaiming their independence.



It belongs to an international network of 103 members in 93 countries, all working to end the commercial sexual exploitation of children. Their mission is to protect every child's basic human right to grow up free from the threat of sexual exploitation and trafficking. Kyra leads the Youth Against Child Trafficking (Y-ACT) program, educating middle and high school youth regarding child sexual exploitation, healthy relationships, and healthy virtual identities. The curricula is designed to educate, empower and develop the leadership skills of young people.

Kyra has recently received her B.A. in Psychology and Statistics at Macaulay Honors College at Hunter College and is currently pursuing her M.A in Public Health at the CUNY School of Public Health.


Human Trafficking – Labor Trafficking

All work or service extracted from a person under the threat of penalty and for which the person has not offered her/himself voluntarily

- Common in the U.S.
 - People forced to work in homes as domestic servants
 - Farmworkers coerced through violence as they harvest crops
 - Restaurants, cleaning services, construction, factories and more

Who Are the Victims?


- All backgrounds girls, boys, women and men

I was groomed.



"When I was 16 years old, I met some older men at the local mall. One of the men started taking me on dates and buying me clothes and meals. Not long after we started dating, he coerced me into sex trafficking, convincing me that if I complied, I would never need to rely on anyone ever again. At 17 years old, I was forced to make at least \$1,000 per day. Eventually, my traffickers forced me to take on a different role where I was in charge of recruiting more teenagers to be exploited in commercial sex. Most of the money went to my traffickers. To keep me under their control, my traffickers threatened my family who lived nearby." —Taylor, Survivor

How Does the Y-ACT Program Work?

- To prevent trafficking from happening in the first place, ECPAT-USA developed our Youth Against Child Trafficking (Y-ACT) program.
- Through facilitated workshops and guided conversations, middle school and high school aged youth in NYC learn about the existence of child sexual exploitation in their communities, what it looks like so they can protect themselves
- Y-ACT's interactive, skills-based curriculum utilizes a holistic, trauma informed approach.

Child Sex Trafficking 101

When thinking about human trafficking, many people picture the kidnapping, physical restraint, and force of girls in developing countries. Students learn about the misconceptions, vulnerable populations, the warning signs of child sex trafficking, and more. The session closes out so that participants leave with concrete steps they can take to help raise awareness about this human rights abuse happening in our backyard.







Healthy Relationships 101

Many survivors of sex trafficking have reported viewing their trafficker as a romantic partner. With this in mind, *HR 101* explores the components of healthy & unhealthy relationships, power & control, consent, and more. The session includes a self-reflection piece so that students can think of ways to make their existing relationships healthier and leave any unhealthy relationships.

Healthy Virtual Identities 101

With the growth of the technology, sex trafficking is rapidly moving from the streets to online venues; traffickers are now using social media platforms to lure in and recruit new victims. To protect our youth from these predators, *HVI 101* explores the components of "healthy virtual identities", addresses the "do's & don'ts" of posting, catfishing, warning signs of online predators, and more. Participants are encouraged to think of ways to make their online identity healthier while still having fun online.



Program Highlights

During the program's first year, two students self-identified as victims of sexual exploitation. Since then, our workshop series has been facilitated to over 6500 youths at 40+ schools and organizations.

For the 2018 academic year, The program reached 1,454 students in public and private schools throughout NYC,

26% overall increase in knowledge acquired about child trafficking.

64% of students were interested in raising awareness about child sex trafficking 84% of students were able to define and give an example of consent 90% of students were able to recognize traffickers use social media during recruitment

These data demonstrate student attraction to this subject and the critical need for this type of education to be provided within the school system.



SIGNS OF ONLINE SEXUAL EXPLOITATION OR TRAFFICKING

This period of social distancing offers an opportunity to monitor for common indicators of trafficking and online exploitation. Below are some behaviors to consider:

- 1) frequently exits and enters the home despite prohibitions on travel;
- 2) works excessively long hours for a new "job" (virtually or outside of the home);
- 3) displays signs of depression, anxiety or unusual fears, or a sudden loss of self-confidence;
- 4) exhibits injuries or other signs of abuse;
- 5) fears authority figures;
- 6) receives sums of money transferred into accounts such as Venmo, CashApp, and PayPal;
- 7) experiences a disturbance from usual sleep patterns;
- 8) spends an increased amount of time online or on the phone, checking in with an unidentified "friend";
- 9) suddenly changes their appearance or style of dress;
- 10) has an increase in package deliveries, money, clothing or jewelry;
- 11) provides inconsistent explanations for any of the above.





The Zonta Club of Greater Queens is a local chapter of Zonta International. Their mission is to advance the status of women, girls and their families through service and advocacy, locally and globally. Statistics on Human Trafficking

Human trafficking is the fastest-growing criminal enterprise in the world, generating more than \$150 billion annually, yet few people know exactly what it is and who it affects.



The United Nations defines human trafficking as the recruitment and/or transportation of persons through force, fraud, or coercion.

Human trafficking occurs when someone in a position of power exploits an individual in a vulnerable situation, typically for financial gain. Traffickers will use a variety of manipulation tactics to undermine a victim's autonomy, some of which include lies and manipulation, physical isolation, and theft of personal identification documents.



The many forms of trafficking:

- Labor trafficking
- Sexual exploitation
- Involuntary domestic servitude
- Forced marriage
- Child soldiering
- Forced begging
- Forced criminal activity
- Organ trafficking





Women and girls

are overwhelmingly the victims of sex trafficking.



In the U.S., there have been cases of human trafficking in all 50 states and Washington, D.C.

In rural, urban, and suburban areas all across the U.S.

Anti-trafficking laws and improved data collection are improving the capacity of countries to respond to human trafficking.
